## Bridal Contract

Thank you for choosing me to glam you up for your big day! Please carefully review this contract and return it to me via email or text. The complete balance for your bridal party will be due on or before your wedding date

Please feel free to contact me at any time with questions or concerns. I look forward to being a part of your happily ever after!

### **Policies:**

**BOOKINGS-** To secure your wedding date, a Signed Bridal Contract is required, as well as a non-refundable deposit of \$50 to secure the date.

**\*\*Contract & Deposit is due within 10 DAYS of being issued. If the contract and payment isn't received within 10 days, it is possible for another wedding to be booked on the desired date.**

I accept Cash, Venmo or Chase Zelle Quick Pay.

**Number of Services** – I require a MINIMUM of 3 services to book my Saturdays! If I arrive Saturday morning and the number of services is under 3 – The bride is responsible for paying the difference.

**\*\*Please note that I am a solo Makeup Artist. If there are more than 6-7 people, I will require an assistant. I will confirm the wedding with you when my assistant confirms with me.**

**Travel Fee-** A mileage fee of (\$1.00 / mile one way) will be charged for travel. This travel fee is separate from makeup fees.

**Liability-** All Brushes, Tools & Makeup products are sanitized between every service. Any allergies or skin conditions should be reported to Rocio the makeup artist prior to service. Client(s) agrees to release the makeup artist from liability for any skin complications due to allergic reactions.

**Payment-** The final balance is due on or before the day of the event, before the makeup artist departs- NO EXCEPTIONS. The person responsible for the

entire payment is the person whose name appears on this contract. On the day of the event payment is preferred as cash.

**Photo Release Agreement-** By signing this contract you are also authorizing the makeup artist to use photos for her website or other social media platforms.

**Prep Instructions-** Please come to your appointment with a clean face.

\* I do offer Dermaplaning Facials and Full service facials prior to the event, That can help prep your skin for a flawless makeup application on your special day! \*

**Contradictions-** By signing this contract you understand I cannot perform makeup services in unsanitary conditions. I also cannot perform makeup if someone has Pink eye, Styes or Cold Sores present. A refund will not be issued if I cannot work due to unsanitary conditions.

**Wedding Day-** I will show up 10-15 minutes before the start time to set up.

- I require there to be outlets for my lighting.
- If I must wait 10 minutes in between services due to the person(s) attendance, an additional \$5 will be charged per 5 Minutes of additional wait time.
